**DISCUSSION/ACTION: STATUS REPORT ON PLAN OF ACTION FOR WORLD LANGUAGE COURSE OFFERINGS**

Assistant Superintendent Barbara Dill-Varga provided introductory comments and an overview to the report from the committee reviewing Glenbrook's World Languages and future needs. Her committee of five was comprised of the two associate principals for curriculum from North (Rosanne Williamson) and South (Cameron Muir) and the two instructional supervisors for the world language departments at North (Ann Koller) and South (Danita Fitch). Mrs. Dill-Varga reminded the Board of the current board policy parameters guiding curricular review as she outlined the parameters of this study which included: 1) identification of initial questions, 2) audit of existing world languages and their enrollment in the Glenbrooks, 3) historical review of changes made in last decade to course offering list in the district, and 4) Two pronged data collection process with research into various current statistics and practices regarding world languages as well as the designing and administering of a comprehensive survey to over 2200 students in the district. The survey data was helpful in understanding implications that might result from any changes to the status quo. The rest of the committee spoke briefly on five issues which emerged from this study:

- stability of enrollment of existing courses
- college requirements: entrance/graduation
- certification requirements for highly qualified instructors,
- placement issues, and
- alignment with world language department goals.

Asst. Supt. Dill-Varga summarized the committee's concluding thoughts that it would be very difficult to embrace the addition of any one of the four new world language courses emerging from the survey data as student choices (Italian, Hebrew, Polish, and Korean) without harmful effects to the existing curriculum.

Board questions sought clarity on various charts in the report and points being made. After a brief discussion board member Boron asserted that he believed that there were actually two questions to address: 1) was there a demand for the language and was there an ability to fulfill that demand logistically. He expressed his opinion that there was a demand for Hebrew at North as it seemed likely that 60 students would take the course, though he was not certain if there was an ability to sustain it. Mrs. Regalbuto identified that similarly there probably was a parallel demand possibly for Korean at South. She underscored that the most recent community group asking for Hebrew should not be the primary group listened to just because they were the last group prior to the initiation of the study. Superintendent Riggle suggested that this study be used as a foundation for further conversation at the July board meeting. He thanked the committee and Mrs. Dill-Varga for their excellent work in compiling these findings and reminded the board that they were well positioned to continue the conversation in July in line with the board process which, if appropriate, would bring a course proposal for approval to the board with other course proposals in January for courses to be added in 2010-2011.

With Board approval, the Board could form a steering committee so that fund raising could begin during the 2009-2010 school year so implementation of tentatively proposed fields could be completed by the end of Summer 2011.

Newer board members had questions which underscored their need to have copies of previous documents regarding the processes and procedures (flowchart) followed for large capital project decision making as well as previous documents and research gathered on the need for and cost of artificial turf fields. Dr. Schilling assured the board that these documents would be provided so discussion could continue at the next board meeting.
